



EDGESTREAM END USER CLIENT SOFTWARE LICENSE AGREEMENT

IMPORTANT: PLEASE READ THIS EDGESTREAM SOFTWARE LICENSE AGREEMENT CAREFULLY BEFORE USING THE FREE EDGESTREAM CLIENT SOFTWARE. BY USING THE EDGESTREAM SOFTWARE AND SERVICES, YOU ARE AGREEING TO BE BOUND BY THE TERMS AND CONDITIONS STATED BELOW. IF YOU DO NOT AGREE WITH THE TERMS OF THIS LICENSE, PROMPTLY CEASE USING THE SERVICE AND UNINSTALL THE SOFTWARE.

a. License. EdgeStream Incorporated ("EdgeStream") grants a nonexclusive and nontransferable license to use the EdgeStream Streaming Client Software in accordance with this License Agreement. This License is not a sale. EdgeStream retains title to the Software, Service, and related documentation, if any. This License allows use of the EdgeStream Streaming Client Software only by one (1) User. "User" means individual Licensee.

b. Disclaimer of Warranty. Licensee expressly acknowledges and agrees that the use of EdgeStream software is at Licensee's sole risk. The software and technical support are provided "AS IS" and without warranty of any kind. TO THE MAXIMUM EXTENT PERMITTED UNDER APPLICABLE LAWS, EDGESTREAM EXPRESSLY DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON INFRINGEMENT.
